About the Event:

This session was organized to sensitize the students, teachers and other stakeholders about the role of IPR in innovation and invention. It was attended by undergraduate, post graduate students, Ph.D. scholars and teaching faculty from various departments.

The program began with the welcome address by Dr. Anuradha J Bakshi (I/C Principal). This was followed by the introduction to the Resource Person by Dr. Minelly Rodrigues.

The Resource person was Mrs. Ujjwal Singh, Examiner of Patents and Designs, Mumbai Patents Office, Department of Industry and Internal Trade, Ministry of Commerce and Industry, Government of India. She exposed the participants to different types of Intellectual Property Rights (IPRs) such as patents, design, geographic indication, copyrights and trademarks. 


