New ordinances 6705 & 6706 relating to the Add On One Year Diploma Course in Indian Sign Language.

(i) Necessity of starting this course

This course helps fulfil our mission of building sensitivity towards individuals with special needs. It is one small step towards helping build an inclusive society in which people with disability experience inclusion and solidarity instead of prejudice and exclusion.

This course is a value addition, enhancing employability of those seeking employment in GOs and NGOs that provide holistic services to visually impaired individuals. It is also a value addition for school and college teachers.

(ii) Whether UGC has recommended to start the said courses?

Yes, UGC has recommended the incorporation of skill-oriented and value-added, add-on courses.

(iii) Whether all the courses have commenced from the academic year 2019-20?

The course will commence in 2022-2023 after obtaining affiliation.

(iv) The courses started by the University are self-financed, whether adequate number of eligible permanent Faculties are available?

Yes, there is an adequate number of eligible permanent Faculty members to coordinate the course and visiting faculty and see to its smooth and effective delivery.

(v) To give details regarding duration of the Course and is it possible to compress the course? A 13-week, 80-hour course.

We have already compressed the course.

(vi) The intake capacity of each course and no. of admissions given in the current academic year (2019-20).

Intake capacity: 25 students

Admissions not given in the academic year (2019-20) as we are awaiting university affiliation. The course will commence in 2022-2023 after obtaining affiliation.

<u>Type of Course</u>: Add-on One-year Diploma course (value-added course). Already running in the college for the past 7 years; we would now like to seek university affiliation.

Online or Offline: Online during the pandemic. Afterwards, we would like two courses, one in online mode and the other in offline mode.

<u>Vision</u>: To nurture students' holistic development through a curriculum and supportive actions that cater to students' emotional, intellectual, social, moral, and employability needs.

<u>Mission</u>: The aims and objectives of this course are aligned with the College Mission. Our students are part of a larger community. This course helps fulfil our mission of building sensitivity towards individuals with special needs. It is one small step towards helping build an inclusive society in which people with disability experience inclusion and solidarity instead of prejudice and exclusion.

Objectives: On completion of this course the students are able to:

- Understand the basic nature of sign language, including the myths about sign language, features and characteristics of sign language
- Sign and interpret signs building a basic vocabulary of 400+ words.
- Sign and interpret signed simple sentences/questions.

Eligibility: Anyone with the motivation to learn Sign Language, no age bar.

<u>Intake capacity</u>: 25 students for adequate interaction, as it is a highly interactive course.

<u>Duration & Number of sessions</u>: 2 hours per session, thrice a week (6 hours/week) approximates a 13-week Course, covering 80 hours.
