

A panel comprising of semi-trained panel members was selected for the evaluation. The panel members were briefed about the products and sensory parameters before the commencement of the evaluation. They were also familiarized with the score card designed for the evaluation. Multiple evaluation booths were set up in the food laboratory to enable each panelist to conduct the sensory evaluation

Quantitative data obtained from the sensory evaluation was subject to statistical analysis using appropriate tests and thereby highlighted the acceptability of each of the product variants. Feedback on the strengths and areas for improvement for each RiteBite Max Protein Granola variant was provided along with recommendations for potential product enhancements based on the findings. Ms. Vibha Hasija (Head- Department of Foods, Nutrition and Dietetics) provided overall guidance for the consultancy project.
